MINISTER OF DEFENCE AND MILITARY VETERANS' SUPPLEMENTARY REPORT TO THE PRESIDENT AND COMMANDER-IN-CHIEF, HE CYRIL MATAMELA RAMAPHOSA ON THE ZIMBABWE TRIP 08<sup>TH</sup> AND 09<sup>TH</sup> SEPTEMBER 2020

Dear Mr President

- 1. Your letter dated 22 September 2020 refers.
- 2. Please find additional information for your report as requested. Included is the copy of the draft affidavit to the Public Protector (Annexure A).
- 3.1. I departed Waterkloof Air Force Base on 08 September 2020 at 18h25 and arrived at Harare Airport at 19h35 that evening. Having concluded the official visit and attending to the meeting with ZANU PF, I departed Zimbabwe on 09 September 2020 at 21h45 and arrived in South Africa at Waterkloof Air Force Base at 22h30. Please see paragraph 11 of the Affidavit attached.

- 3.2. The pax list is attached (Annexure B), please also find attached, the list of the official delegation as per Ministerial Authority (Annexure C). Furthermore a letter from my counterpart confirming our meeting (Annexure G) and a media report (Annexure H)
- 3.3. I obtained your approval to travel internationally on the official visit to engage bilaterally with my counterpart. I agree in hindsight that it would have been prudent to inform your Office in writing of my intention to ferry ANC NEC members of which delegation I formed part to meet with ZANU PF counterparts. Paragraph 1.2 of Chapter 7, Use of Non-commercial air travel, in the Guide for Members of the Executive, approved by the President on 20 November 2019, provides as follows: Air transport provided by the South African Air Force or any other Government Department may not be used by Members for party political engagements, unless such transport enables the Member concerned to fulfil important official engagements before or after the party political engagements.

In my understanding of the above quoted paragraph, I did not need additional permission to attend to party political engagements using the same SAAF flight as such has already been catered for in the Ministerial Handbook. As to the ferrying of additional persons on the same aircraft, I am not aware of any prohibition on doing such or specific permission that ought to be sought as it is a regular occurrence in the use of SAAF aircraft to provide for the ferrying of business persons or the like if all are travelling in the same direction as the flight being used for official Government purposes.

3.4. The delegation had to be tested before departure. Self-quarantine certificate (Annexure D), was sought from the Department of Health. Over flight clearances were obtained by the SAAF.

Paragraph 1.5 of Chapter 7, Use of Non-commercial air travel, in the Guide for Members of the Executive, approved by the President on 20 November 2019, provides as follows: The South African Air Force may further assist Members with flights abroad,

which cannot be provided for by commercial airlines, if such flights are within the capacity of the South African Air Force.

Paragraphs 1.6 and 1.7 of Chapter 7 are also applicable to be followed in such instances where SAAF aircraft are to be used:

- 1.6. All applications for the provision of air transport by the South African Air Force must be made to the Secretary of Defence, in advance, to establish the availability of aircraft, flights and landing strips.
- 3.5. Please find attached relevant permission, i.e. Presidential Authority (Annexure E).
- 3.6. The total cost are calculated as follows, the flying hour tariff of R62 000.00 per flying hour is a product of the approved model. The average hourly fuel consumption of 1500 litres for both engines is derived from various stages of flight for this type of aircraft. Therefore the direct cost for a 2.7 hour flight can be calculated as follows;

 $R62,000.00 \times 2.7 = R167,400.00$ 

And

1500 Litres x 16 (ROE) = R24, 000.00 per flying hour

Thus

 $R24,000.00 \times 2.7 = R64,800.00$ 

Total: R167, 000. 00 + R64, 800.00 = **R232, 200.00** 

Total due to the African National Congress Delegation **R105**, **545.46** as per attached Invoice (Annexure F).

3.6.1. For international travel on the continent the MOD uses the Falcon 900 or similar sized chartered aircraft. The Falcon 50's is used only for internal travel as a rule. Thus I would have used the Falcon 900 or similar size chartered aircraft given that commercial flights are not available regardless of whether additional ANC NEC members joined my visit or not.

I attach all annexures I refer to in the draft affidavit some of which are also referred to above.

#### **AFFIDAVIT**

I, the undersigned,

## NOSIVIWE NOLUTHANDO MAPISA-NQAKULA

do hereby make an oath and state that:

- I am the Minister of Defence and Military Veterans. I have been requested by the Public Protector to provide this affidavit. A copy of the request for information is attached hereto as Annexure A.
- 2. The contents of this affidavit are, unless the contrary is clear from the context, within my personal knowledge and are, to the best of my knowledge, both true and correct. I have also relied on records and responses from my Department, which I believe to be accurate in response to requests for information not kept within my Office.
- I shall structure this affidavit as follows:

- 3.1 The organisation/arrangement of my official visit to Harare, Zimbabwe, to meet my counterpart, the Minister of Defence and War Veterans, Ms Oppah Chamu Zvipange Muchinguri-Kashiri from 8 to 9 September 2020;
- 3.2 Ad paragraph responses to the request for information.

# OFFICIAL VISIT TO THE REPUBLIC OF ZIMBABWE: 8-9 SEPTEMBER 2020

- 4. The Republic of South Africa plays a critical role in regional, continental and international structures to work towards the achievement of peace and security on our continent through our participation in structures at the level of the Southern African Development Community (SADC), the African Union (AU) and the United Nations (UN). Apart from these multi-lateral arrangements we also pursue these goals through bi-lateral arrangements and in the case of the Republic of Zimbabwe we have an ongoing Defence Cooperation Agreement and participate in the meetings of the Bi-National Commission.
- 5. The Republic of South Africa and the Republic of Zimbabwe are both currently members of the SADC Troika. South Africa, as a troop contributing country to the MONUSCO Force Intervention Brigade (FIB), in the Democratic Republic of the Congo, has been seized over the last two months together with other SADC members and especially the Troika members with discussions on the way forward in regard to the continued existence and composition of the FIB in light of recent changes proposed by the UN. As countries neighbouring Mozambique we have also been engaged bi-laterally and through the meetings of the SADC Troika and SADC as a whole with the disturbing reports emanating from that country in relation to alleged insurgencies and terrorist activities.

- 6. It is in the context of the above background that I contacted my counterpart, Ms Oppah Chamu Zvipange Muchinguri-Kashiri, the Minister of Defence and War Veterans in the Republic of Zimbabwe, on 7 September 2020, to request an official visit to allow us to conduct a bi-lateral meeting to focus on these matters at hand. I attach hereto as Annexure B a copy of the letter written to my counterpart.
- 7. The Honourable Minister of Defence and War Veterans Affairs of Zimbabwe responded on the same day by accepting my request for an official meeting to discuss bi-lateral defence and security issues in the usual face to face fashion as such had been impeded over the last couple of months by the onset of the Covid 19 pandemic. A copy of the letter from Minister Muchinguri-Kashiri is attached hereto as Annexure C.
- 8. Subsequent to the above exchange of official communication between our respective offices and having secured my official meeting with my counterpart in Zimbabwe for the 9<sup>th</sup> of September 2020, my Office proceeded to prepare the request for approval of the official visit to the President and to request that the Honourable Minister Nkosazana Dlamini-Zuma be appointed as the acting Minister of Defence and Military Veterans. A copy of the request is attached hereto as Annexure D.
- 9. The President approved, by means of President's Act No. 108 of 2020, my request to travel to Zimbabwe and appointed the Honourable Dr NC Dlamini-Zuma as Acting Minister of Defence and Military Veterans. A copy of the letter of approval is attached hereto as Annexure E.

In August 2020, the President of the Republic of South Africa, His Excellency, 10. President MC Ramaphosa, appointed and dispatched Special Envoys to engage the Government of Zimbabwe on developments within that country, which impact on South Africa. Following on this engagement a decision was further taken to send a delegation of members of the National Executive Committee (NEC) of the ruling party, the African National Congress, to meet with their counterparts in the ruling ZANU PF party in Zimbabwe. I was to form part of this delegation as a member of the NEC. I was already set to depart on the Falcon 900 aircraft of the South African Air Force<sup>1</sup> and since normal international travel had not resumed due to the Covid 19 pandemic and given the urgency of the matters to be discussed, I offered to ferry the members of the ANC delegation to and from the meeting in Zimbabwe.<sup>2</sup> Given that my official visit to meet my counterpart had been approved and that the Ministerial Handbook as quoted below allow me to also attend to party political engagements in these circumstances and the fact that the costs to be incurred for the SAAF flight would remain the same whether it is just myself on the plane or others joined me, I extended the invitation to ferry the ANC NEC members.3 However, shortly after returning to South Africa the top structures of the ANC met and thereafter offered to reimburse the costs incurred for their delegation that joined my flight to Zimbabwe. The costs have been calculated using the model prescribed in paragraph 1.8 of the Guide for Members of the Executive when another Department used SAAF aircraft

and is set to reimburse the Department of Defence.<sup>4</sup> The invoice issued to the ANC is attached as Annexure F.<sup>5</sup>

11. I departed Waterkloof Air Force Base on 8 September 2020 at 18h25 and arrived at Harare Airport at 19h35 that evening. Upon my arrival I was met at the airport by my counterpart, Minister Muchinguri-Kashiri, and we had a quick courtesy briefing at the airport for less than an hour. Thereafter I departed with my delegation to the Meikles Hotel to spend the night. On 9 September 2020, I formed part of the meeting of the ANC NEC officials with party officials from ZANU PF from around 10h00. That meeting continued until about 19h00. I broke away from that meeting to conduct my official visit with my counterpart at 16h30. We finished our bi-lateral engagement at around 19h00 and then issued joint statements to the media at about 19h30 from the Meikles Hotel. I attach hereto a copy of a news clipping carried by the Zimbabwe media on our bi-lateral talks (Annexure G). I departed Zimbabwe on 9 September 2020 at 21h45 and arrived in South Africa at Waterkloof Air Force Base at 22h30.

# AD PARAGRAPH RESPONSES TO THE REQUEST FOR INFORMATION

#### 12. Ad paragraph 5

As explained above, I travelled for official purposes to engage my counterpart in a bilateral discussion on matters relating to the security situation in Mozambique and discussions on the continuation and composition of the FIB in the DRC, given our

roles as part of the SADC Troika. At the same time, I offered to ferry members of the ANC NEC to attend a meeting of which I formed part as explained above in paragraph 10. The complainant is therefore mistaken in referring to the purpose of the flight and the composition/leadership of the delegation as "common cause" in the manner it is captured in paragraph 5.

# 13. Ad paragraph 6

The utilisation of the SAAF aircraft has been explained above. It must be pointed out that the Chairperson of ZANU PF also happens to be my counterpart (she is the Minister of Defence and War Veterans Affairs of Zimbabwe). She met me, as is tradition upon arrival for an official visit in another country, at the airport for a brief curtesy visit before our official meeting which was to take place the next day.

# 14. Ad paragraph 7

As pointed out above, I travelled to Zimbabwe on an official visit for a bi-lateral engagement with my counterpart and also happened to form part of the ANC NEC delegation, whom I offered to ferry since I was already travelling to Zimbabwe on a SAAF aircraft and given the non-availability of commercial flights as a result of the pandemic.<sup>6</sup>

# Ad paragraph 8

The ANC issued its own statement on matters relating and relevant to its engagements. As pointed out above, I left the meeting of the ANC officials to

The attached copies of the exchange of correspondence with my counterpart and the Presidential approval for the official visit, as well as the media coverage of my engagement, confirm the agenda and nature of my bi-lateral discussions with Minister Muchinguri-Kashiri.





# , SA defence ministries share notes

Zimbabwe and South Africa's defence ministries held bilateral-talks in Harare this Wednesday where they shared notes on a wide range of issues affecting the two countries.

South Africa's Minister of Defence and Military Veterans, Ms Nosiviwe Mapisa Nqakula and Zimbabwe's Minister of Defence and War Veterans Affairs, Cde Opah Muchinguri-Kashiri met in a closed-door session.

"We had quite an intense discussion on matters of mutual interest as you know Zimbabwe was head of the Troika of SADC and South Africa is also part of that Troika. The other thing we had to consult on is the Friday meeting of the UNSG with ministers of the region so it was important for us to meet, discuss and agree and also to discuss issues of defence to defence relations and the areas were our generals are cooperating."

The two ministers also discussed the current situation in Mozambique as well as ways to deal with the porous border between South Africa and Zimbabwe, especially during the Covid-19 pandemic.

Dear Minister Mapisa-Ngakula

RE: COMPLAINT TO THE PUBLIC PROTECTOR RELATING TO ALLEGATIONS OF MALADMINISTRATION IN THE OFFICES OF THE PRESIDENT OF THE REPUBLIC OF SOUTH AFRICA AND THE MINISTER OF DEFENCE AND MILITARY VETERANS.

Kindly take note that I have received a complaint from Mr Vuyolwethu Zungula,
 MP who is the President of the African Transformation Movement (the Complainant).

- Similar complaints were lodged by Mr Hurter Spies on behalf of AfriForum on 10 September 2020 and captured under reference number 008212/20 and by Dr Pieter Groenewald, MP, on behalf of the Freedom Front Plus on 11 September 2020 under reference number 008206/20.
- The complaints have been consolidated due to their similarities and investigated under reference number 008213/20. Kindly quote this reference number in all further correspondence relating to this matter.
- The investigation is conducted in terms of section 182(1) of the Constitution of the Republic of South Africa, 1996 read with sections 6 and 7 of the Public Protector Act, 1994.
- 5. In the letter of complaint, the Complainant alleges that it is common cause that on 09 September 2020, a delegation of the African National Congress (ANC) led by their Secretary General, Mr Elias Sekgobelo "Ace" Magashule landed in Harare, Zimbabwe.
- 6. It is alleged that it is also common cause that the aircraft of the South African Defence Force was used to transport the ANC delegation. They were met in Harare by Zanu-PF Chairperson, Ms Oppah Muchinguri Kashiri and several other Zanu-PF officials on arrival.
- It is alleged that it is common cause that the ANC delegation included yourself and various other members of the National Executive Committee (the NEC).
- 8. It is also alleged that it is common cause that on 10 September 2020, the ANC issued a public statement to give feedback on what was deliberated upon in the meeting. What is noteworthy about the statement, which was issued by the ANC's national Spokesperson is that nothing involving military issues was mentioned.

- The Complainant contends that media reports attributed to your Spokesperson,
   Mr Siphiwe Dlamini stated that the ANC meeting coincided with your official in Harare, Zimbabwe.
- 10. It is contended that Mr Dlamini is reported to have said that you were meeting your Zimbabwean counterpart in preparation for a SADC Troika meeting and the UN reconfiguration of the Force intervention which comprises troops from the SADC region. You have not repudiated Mr Dlamini's statement and therefore, it is safe to conclude that you agree with his version.
- 11. It is also contended that President Cyril Ramaphosa issued a statement on 11 September 2020 instructing you to furnish him with a detailed report within 48 hours on the circumstances that led to you sharing a flight to Zimbabwe with a delegation of the ANC leadership.
- 12. The Complainant has requested that I investigate the following:
- 12.1. Confirmation whether the meeting with your Zimbabwean counterpart indeed took place and if so, the agenda discussed during the meeting. It was contended by your Spokesperson that you were meeting your Zimbabwean counterpart in preparation for a SADC Troika meeting and the UN reconfiguration of the Force intervention which comprises troops from the SADC region;
- 12.2. Whether you submitted a request for approval to President Ramaphosa in line with Chapter 6, paragraph 1.3 of the Guide for Members of the Executive (Ministerial Handbook), if so, whether the request was approved by President Ramaphosa. Paragraph 1.3 of the Ministerial Handbook effective from November 2019 provides that:

"Ministers and Deputy Ministers should approach the President in writing to request approval for the intended visit and in the event of a planned official visit

abroad, such request should be at least two weeks prior to departure. Such

request, in the case of a Minister, should be accompanied by a request for the

appointment of an Acting Minister."

13. You are requested to provide the following:

13.1. All relevant documentation pertaining to the alleged trip to Harare, including all

correspondence between your office and that of your counterpart where the

logistics of the trip and the purpose of the meeting are discussed;

13.2. A written account under oath of your whereabouts from the time you landed in

Harare, Zimbabwe on 09 September 2020 to when you boarded the flight back

to South Africa;

14. You are requested to provide, within 14 (fourteen) calendar days from the date

of receipt of this letter, a response to the allegations narrated in this letter and

attach copies of all documentation relevant to this matter which are in your

possession or under your control.
